- The Aberdeen Standard Multi-Asset Real Return Fund ('the Fund') is a dynamically managed multi-asset objective-based strategy, which aims to achieve a real return (return above inflation) and may comprise capital and/or income.
- The Fund targets 5% per annum over inflation (RBA Trimmed Mean CPI) before fees over a full market cycle. Aberdeen Standard Investments ('ASI') estimates that over the long term this equates to approximately 7.5% p.a. Approximately 70% to 90% of the returns are expected to be driven by asset allocation decisions with the balance from security selection. A maximum volatility of 10% p.a. is targeted (circa two thirds of equity markets), although historically it has ranged between 5% and 7% p.a.

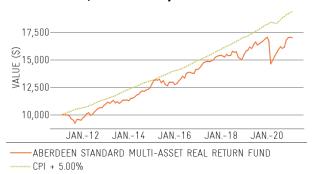

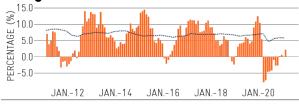
