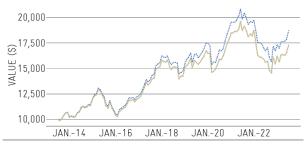
#### What is this Fund?

The Underlying Index is a rules based market capitalisation weighted equity index comprising the large and mid cap sectors of emerging markets, as defined by MSCI Inc. ('MSCI' or 'the Index Provider').
