To outperform the RBA Cash Rate Total Return Index by 1.0% to 1.5% over a rolling three year period before fees.


What is this Fund?

- The State Street Floating Rate Fund (the 'Fund') invests primarily in floating rate notes ('FRNs') issued by banks and financial institutions, and short-term money market instruments (overnight cash and certificates of deposit). All securities are denominated in Australian dollars with a bullet maturity of 5-years or less. The Fund seeks to outperform the RBA Cash Rate Total Return Index over a rolling three-year period before fees. It The Fund also aims to deliver regular monthly income that varies with the level of interest rates.
- The Fund is managed by State Street Global Advisors ('SSGA' or 'the Manager').

What this Rating means
